Elisabeth Ludeman Center Updates Kelly D. Richards, Center Director March 29, 2017

Greetings from the New Center Director

I would like to introduce myself to the Parents and Friends of Ludeman Center Organization. I hold a Bachelors of Arts in Public Administration. I previously worked for DHS with the Division of Family and Community Services. We administered the Cash, Medical and Food Stamp program for the State of Illinois. I have worked for the State of Illinois for 17 years in various management positions. It is my belief that my previous work experience working for the Division of Family Community Services coupled with my personal experiences and my education, demonstrates my ability and commitment to serve as the Center Director. I have a commitment and passion for leadership development and working with staff at all levels and positions. I started at the Elizabeth Ludeman Center on December 16, 2016. I am dedicated to providing a supportive and nurturing environment for the Individuals that reside at the Elizabeth Ludeman Center. I understand the challenges and hard decisions that families have, for I too have a family member with Developmental Disability challenges. I am committed to ensure that every individual is provided with the most optimal care possible. It is my personal goal to make Ludeman the model State Operated Developmental Center in Illinois.

INSPECTIONS/TAGS/and Peer Reviews

Ludeman Center was cited with two tags on February 9th, 2017. The Tags were W153 and W154, which were related to not completing a thorough investigation and not contacting Public Health. A plan of correction has been developed and In-Servicing has been completed in an effort to reduce repeat tags. Additionally, there will be a Peer Review Survey conducted at Ludeman on April 11th-13th. The Peer Review will be conducted by staff from other SODC Facilities, where they will perform a mock survey similar to what IDPH conducts. This internal review affords the center an opportunity to address any areas that may need improvement to ensure that we can maintain certification. Having a successful Peer Review ensures that the Ludeman Center is taking measures to remain certified as an Intermediate Care Facility/Developmentally Disabled (ICF/DD) residential provider in the Federal Medicaid program.

The Center is currently in substantial compliance with ICF/DD Regulations. IDPH came to Ludeman on March 24th regarding a complaint and to review two incidents and they exited on March 29th with no deficiencies cited!

OTHER INFORMATION

On March 29th, we held our Annual Women's Day Program to honor Women in History. Our Keynote speaker was Dr. Diane Washington, Chief Clinical Psychiatrist. She provided a powerful message to the women that attended the program. One individual gave a beautiful rendition of the Lord's Prayer.

We continue our efforts with monthly Open Forums for staff to voice issues and/or concerns that impact the Center. Our next Open Forum is tentatively scheduled for April 4th and 5th.

In the month of February, nine of our individuals attended two Taekwondo trainings near Springfield, led by Commander Heart from the Department of Corrections. On February 16, 2017, Ludeman had eight individuals demonstrate the skills that they learned in training and engage in finally testing before receiving their yellow belts in Taekwondo. All the individuals were very excited about their opportunity to demonstrate their proficiency.

We held a Tech Select in February where seven trainees and seven transfers started March 16, 2017. We also have 18 staff participating in Tech III training which started March 6, 2017. We have promoted 4 RN1's to RN2's. Consequently, that has created a vacancy of 4 RN1's that we are currently attempting to fill. We have lost 3 staff in March due to retirement and anticipate the loss of a Social Worker, Cook, and Qualified Intellectual Development Professional.

Ludeman has some staff changes to announce. One nurse was promoted in the month of February to the Director of Nursing. Our Dietary Manager was promoted to Public Service Administrator in Dietary.

We are receiving donated White Sox tickets for April and May, with the hope that the White Sox will be offering more tickets throughout the season!

Ludeman continues our efforts in working with Cornerstone Services to start a Laundry Training Program that will provide training for our individuals, while also cleaning the linen for the facility. We hope to begin this program sometime this Spring.

We are planning for an Active Shooter Drill and will have a Table Top Discussion sometime in May or June.

Overtime is currently at 19.19% due to the significant staff shortages and call offs! We had seven Techs that retired at the end of December from one Unit alone and anticipate that additional staff are planning to retire this spring. We are continuing our efforts to reduce OT and meet our OT budget goal of 10%. We have opened up a Compliance Department that will track our call offs and help balance the overtime. We are attempting to hire staff for overtime 2 days in advance to help reduce the number of staff that are mandated to work. We are exploring the prospect of hiring retired RN's for 75 days in order to address our nursing shortage.

I look forward to working with each of you, to make The Ludeman Center the best SODC there is! Thank you, Parents & Friends for your continued support. I look forward to serving our individuals, Parents and Friends in the capacity of the Center Director.

3 IMPORTANT ISSUES TO BE AWARE OF & INVOLVED IN...

1. Guardianship Bill – A really terrible idea for a bill (HB2665) continues to be advanced despite overwhelming negative feedback from so many parents and guardians. The idea behind the bill proposed by Rep. William Davis (D, 30th District) would be to require guardians (even parents and legally appointed guardians) to complete a 4-6 hour training program designed by the Office of State Guardians (OSG) in order to maintain their guardianship status. According to the proposed statute, failure to complete this training would take way your guardianship rights and an OSG, a state appointed guardian, would take over your responsibilities.

OSGs have always been 'guardians of last resort' for those who have no one else to look out for them. This bill may <u>or may not</u> be well-intentioned, but as one critic described it "it's a solution in search of a problem that doesn't exist". Minimally, it adds an unnecessary legal hurdle to those who have spent a lifetime caring for and looking out for their loved one. And at worst, this bill is a sinister effort to strip away guardian rights from family members. Let's remember that it has often been individuals with an OSG who are the 1st to be pushed out of their SODC homes and into often times inappropriate CILAs (Community Integrated Living Arrangement). (See #2 below). Many of you have followed this issue on the PFLC website. Continue to do so and please contact Rep. William Davis (708-799-7300 District Office & 217-782-8197 Springfield Office) and your state representatives. Express your strongest opposition to this bill.

- 2. Suffering In Secret The excellent Chicago Tribune watchdog series, Suffering in Secret, is still available for viewing through links on the PFLC website (ludemanpflc.org). The article addresses the appalling lack of oversite of many CILAs throughout the state and details what can be the dangerous and devastating result of this. In contrast, the Ludeman Center operates under the SODC system which requires frequent, ongoing, and recurring state inspections and oversight. There is nothing similar in place for the CILAs. Good journalism can have a powerful effect and the Chicago Tribune series has sparked General Assembly hearings and impetus for the Illinois Department of Human Services to begin addressing this serious problem. If you haven't already done so, be sure to read this important series and follow-up articles.
- **3. AFSCME Takes Strike Authorization Vote** The ongoing contract impasse between the Governor and AFSCME union members continues. AFSCME workers have been working without a contract since their current contract expired in July 2015. Failure of the two sides to come together led to a strike authorization vote being taken at the end of February. It was approved by AFSCME members. This does not mean that a strike is imminent, but it clearly brings the possibility a very real step closer. Updates will be on the PFLC website.

Again, we need PFLC members to raise their voices. **Contact Governor Rauner, legislators, union leaders,** and local papers with the message that both sides need to get back to the bargaining table and arrive at a fair and equitable contract. Let them know that a strike in a facility like Ludeman Center would be reckless and would create a real danger to its residents.

2017 VOR Washington, D.C. Conference

Paul Keipert, our PFLC Treasurer and Board Member, has volunteered to attend the VOR Conference to represent the PFLC Intellectually Disabled in Washington, D.C. from June 3 – 7th. Paul will be walking the halls of Congress to visit each office of our Illinois Legislators. Thank you, Paul, for devoting your time and talents to this important conference.




Ludeman Dream Gardeners News
