# LATEST UPDATE ON FEDERAL LAWSUIT

After numerous delays, our Federal Lawsuit finally moved forward. The Preliminary Injunction Hearing took place on January 7<sup>th</sup> through 9<sup>th</sup> 2014 before Federal Judge Marvin Aspen in U.S. District Court in Chicago.

Along with PFLC, this Federal Lawsuit is being spearheaded by IL-ADD (Illinois League of Advocates for the Developmentally Disabled), the Murray Parents Association, & parents groups from the other five remaining State Operated Developmental Centers (SODCs).

In the suit, we argue that the current process being used by the Illinois Department of Human Services to close Murray Developmental Center and other SODCs is in clear violation of guardian rights and of residents' rights to appropriate levels of service. Our attorneys cite, in part, the Americans with Disabilities Act and the Medicaid Act, as the basis of the state's violation of federal law.

Our lead attorney, Judith Sherwin, said in her opening statement that this lawsuit isn't solely about the potential closing of the Murray Developmental Center, but will instead "determine for many years to come how Illinois cares for people with developmental disabilities."

Over three days of testimony, the court heard from Kevin Casey, the Director of the Illinois Department of Human Services; Mark Doyle, who was appointed by Governor Quinn to oversee the closing of the SODCs; and Rick Starr, current Center Director at Murray; among others.

Arguing as expert witnesses for our side were Rita Winkeler, President of the Murray Developmental Center Parents Group; Tracy Howell, a nurse from Murray Center; and Greg Shaver, a psychologist and director of the Kaskaskia Workshop in Centralia; among others.

As is the case in trials of this magnitude, the wait for a verdict can be a long one. We do not anticipate a decision from Judge Aspen until April or May. Regardless of the verdict though an appeal by one side or the other is still likely.

# NEWS FROM GLENDA M. CORBETT, CENTER DIRECTOR March 2014

### STATUS OF SURVEYS AND INSPECTIONS

At the present time, the Ludeman Center has 3 outstanding standard level tags W227, W249, and W460. All other tags were cleared from our 2013 Annual Survey. The Center is currently in substantial compliance with ICF/DD Regulations. ICF/DD Regulations are the standards that the Ludeman Center must comply with as evaluated during surveys conducted by the Illinois Department of Public Health (IDPH) and/of Federal Surveyors from the Centers of Medicare and Medicaid Services (CMS). The Ludeman Center last underwent an Illinois Department of Public Health (IDPH) Annual Certification Survey with Federal Partnership on September 20, 2013.

As an outcome of the follow-up survey, the Ludeman Center received only 3 repeat Standard Level tags. No Immediate Jeopardy Citations or Conditions of Participation which are considered serious issues were issued. The success of Public Health Surveys ensures that the Ludeman Center remains certified as an Intermediate Care Facility/Developmentally Disabled (ICF/DD) residential provider in the Federal Medicaid program. Doing so means that Ludeman Center will continue to bring back to the State of Illinois approximately one-half of Ludeman's operating budget. Maintaining certification is an extremely important measurement of the level of quality care and services we currently provide to the 418 people with developmental disabilities residing at the Ludeman Center.

Our Life Safety Survey was conducted on September 22 thru September 28, 2013. We were cited with 15 standard level Life Safety tags which have been corrected.

### FISCAL YEAR 2014 BUDGET

**Old Business** - Ludeman's budget for Fiscal Year 2014 (07/01/13 through 06/30/14) is once again scarce but there are no major program cuts for human services in the Governor's budget. A new AFSCME contract that includes \$61.5 million in raises for AFSCME workers was passed. I will give an update on the new budget within the next few months.

New Business-We have been blessed. We are scheduled to receive 41 new full-time technicians. Every effort continues to be made to fill critical staff vacancies as they occur. However, the process of filling staff vacancies remains very time consuming and is often filled with delays as we have to wait on signatures from several different levels. Even with a plethora of obstacles we remain optimistic. We received the final approval from the Governor's Office to appoint Regina Y. Jackson into the Assistant Center Director position. She was officially appointed on September 16, 2013. Unfortunately, Ms. Jackson has made the decision to retire effective April 30 of this year. Thank you all for your efforts in ensuring that Ludeman received permanent leadership. We will definitely keep you all in the loop while we search for a replacement for Ms. Jackson. We will have a retirement party for her so please come out and wish her well.

Ludeman's overtime is currently at 17.38%. We are working hard to reach our goal of 8%. We saw a 4.3% drop in overtime in the last 2 weeks of February. The 41 new technicians are schedule to start April 16, 2014. Ludeman Center staff continues to do their best to provide the high quality care and services you expect from us. Resources are stretched more than ever and many staff continue to perform additional/extra duties and functions. As staff and other resources change, everyone at Ludeman remains well aware of the very important responsibility we all have to meet the needs of everyone who lives at the Center. Our focus will never divert from our obligation to provide high quality care and services within a safe and secure environment. Client protection is our most important responsibility. We intend to continue to meet these obligations.

### MURRY DEVELOPMENTAL DISABILITY CENTER CLOSURE

As you all are aware, litigation is on-going. In the interim, The Division of Developmental Disabilities within the Department of Human Services remains confident that at some time they will be able to continue to work with the

individuals, family members, guardians and their individual support teams to implement the closure while assisting in the relocation and transition for each resident.

Everyone knows this has been a challenging time and it is important for all of us to understand the importance of supporting the people currently being served at SODC's and their families with dignity and respect throughout the continued closure and transition activities statewide.

## OTHER INFORMATION

Ludeman's Dietary Services remains temporarily located at the Oak Forest Hospital. The construction process has begun and we are schedule for a May opening of our new dietary kitchen.

Parking / Road Issues: Nursing staff will no longer be able to use flashing lights in the fire lane. According to Director of Operations, Sam Osun, he has spoken with the Chief of Police and parents picking up their loved ones should use their hazard lights when picking up and dropping off. Any questions, feel free to contact Dr. Osun at 708-283-3009. We continue to wait patiently on final approval for the 2 million in funds to repair roads and parking lots.

The Short Term Admit program is progressing very well. 15 individuals have been successfully transitioned back into the community.

The "Ludeman Community Medical Training Rotation Program" is also going very well. As you all are aware, we had our first student begin residency in November of 2012. We have partnered with Medical Schools to allow their resident physicians, medical students, nurse practitioner students and physician assistant students to complete part of their residency at the Center by shadowing our physicians, etc. The goals of the program are to educate medical students on the rehabilitation needs of individuals in Developmental Centers, Integrated Primary Medical Care, Preventive Medicine/Geriatric Medicine, legal issues involving medical care of those determined to be legally incompetent of making their own medical decisions and assessment of intelligence quotient and its implications in medical care.

We reestablished a partnership with Governors State University and had our first student begin interning back in September 2012. Since then we have had 5 new interns. Governors State University's College of Health and Human Services and the Department of Psychology and Counseling will continue to bring new innovative ideas to the Center.

"Café 64" has 2 new "graduates"!!! They started employment with Daddy Donuts in Park Forest, IL on Friday 3/14/14!!! Please support Daddy Donuts located at 3724 Sauk Trail, Richton Park, IL. The owner is Feda Ibrahim. Stop in and say hello to the first Café 64 graduates!

We are currently collaborating with Southwest Community Services on another outstanding program. We are establishing the "Ludeman Community Clinic" which will offer specialty clinics to individuals being served in the community. We are looking at a Grand Opening sometime in May.

The garden staff has begun greenhouse seed planting for the "Ludeman Garden". We are looking forward to the fresh produce, which will be used in the Snackery and sold to local restaurants. We plan to open a "market" which will be open to the community. We plan to sell fresh flowers, houseplants, and produce.
