2019 VOR Washington, D.C. Conference

I was honored to represent all of you and your loved ones at the 2019 VOR Annual Conference in Washington DC, from Saturday, June 8th though Tuesday, June 11th. 2019 was my seventh year attending this valuable conference.

Let me start by expressing my gratitude: to the board and all the general membership of PFLC for sponsoring my conference registration, hotel accommodations and ground transportation. Thanks to my mother-in-law, for donating her airline miles for my flights. A huge thank you goes to Rita Winkler from ILADD and the Murray Center Parents Group for arranging all the Congressional office appointments. Special thanks to VOR for all the planning and arrangements that they do behind the scenes to make the conference a success.

Saturday afternoon was the time for individual member state reports. So many states have disturbing stories of failures of severe and profound Intellectual and Developmental Disabled (I/DD) who have moved into "community" settings, about closures of more of the congregate Intermediate Care Facilities, and how changes have been made or are planned in how Medicare/Medicaid is being funded and managed in some states. When Rita Winkler gave the Illinois report, I again realized how blessed we in Illinois are to still have seven State Operated Developmental Centers (SODC) with no active threat to their existence, and that some new admittance has occurred at some centers. On Sunday there were three presentations. First was a very uplifting presentation by Melissa Stone, who is the Director of the Division of Developmental Disabilities Services at the Arkansas Department of Human Services. Next, James Edmondson, M.D. PhD. had a presentation about Medicaid Managed Care. Amy S. F. Lutz is a parent of an Autistic child and is the founder of the National Council on Severe Autism, EASI Foundation. You can find links to YouTube versions of the presentations at https://www.vor.net

In our legislative visits we asked for Congress to support Medicaid funding for people with I/DD without changes that would reduce these critically necessary funds. Also, we asked for their support of the HEADs UP Act of 2019. This bill would designate people with I/DD as a Medically Underserved Population, providing them with better funding for primary and specialized care, incentivizing new research, and authorizing more favorable reimbursement rates for providers who treat this population.

We asked for support for the Autism CARES Act of 2019, which would extend the Autism CARES Act of 2014 and provide for further research into the causes, diagnosis, and early and ongoing detection, prevention, and treatment of autism spectrum disorder.

Most importantly, we asked our legislators to oppose the Disability Integration Act of 2019. This act would eliminate individual or family choice of residential settings for individuals with I/DD, strain federal and state budgets for Medicaid, and overturn key provisions in the landmark 1999 Supreme Court decision in Olmstead. These bills exist in both the House and the Senate, and have significant cosponsors in both parties. Both versions have strong language to close down congregate facilities, moving the entire ID/D population into the community, seemingly ignoring all of the important rights granted by the Olmstead decision. A group called ADAPT has done a real blitz on both houses of Congress to raise support for these bills, and many legislators that have agreed to cosponsor the bills don't see the destructive effect on SODCs and other congregate facilities as VOR sees it.

Finally, we asked that Congress oppose both the Raise the Wage Act and the Transformation to Competitive Employment Act, as long as they contain provisions that would eliminate work opportunities for some individuals with I/DD whose disabilities are so severe they are unable to perform tasks sufficient to warrant the payment of a minimum wage.

Overall the visits went well. Some of the aides we spoke with were not well versed in the issues or were new to being an aide. For these, our presentations were more basic to make them aware of the existence of severe and profound ID/D people and their service needs. Others were very knowledgeable and remembered VOR from previous visits, and with these we could talk more about the specific bills and our specific "asks." I included a wonderful montage of PFLC event photos to show the aides and that really helped make the issues real.

When I spoke, I told my brother Glenn's story of how he had been on a waiting list for Misericordia and was admitted at age eleven. However, before he had been there for two years, he was unable to stay at this esteemed facility. They could not handle an individual like him because of his explosive and self-injurious behaviors. He was sent to Reed Mental Health center for almost a year before a placement was found for him at the relatively new Elisabeth Ludeman Development Center. Only ELDC accepted, kept, and cared for him. Now for over four decades Glenn has been a resident of Ludeman and the staff has done wonders for minimizing his behavioral issues. I hoped that the story would enforce the idea that if a place with the reputation of Misericordia could not help Glenn because of his needs and his situation, that it is unlikely that a community setting could help him.

I think my favorite moment was when we were discussing opposing the Disability Integration Act, a legislative aide looked it up and to her horror saw that her Congressman had indeed signed up to cosponsor the bill. As she dug a little deeper, she then said "In my defense, I was not working for the Congressman at the time!"

Many of the aides praised us as individuals for coming to Washington to present our stories and our views. They said it is a very powerful testament and has much more weight when individuals make such visits, over the visits that they get from the so-called advocacy groups.

"The measure of a civilization is how it treats its weakest members."

By this measure, the state of Illinois seriously fails a special population that is easy to ignore and exploit because they are vulnerable and voiceless. That's why it's imperative that we all be their voice. Let's make sure the Ludeman Center and the other six SODCs continue to be there for all those with such very special needs.

This is my sister, Jeanne Haley. She is 63 years old, but functions mentally as a one year old.

She doesn't know how to talk, but she does vocalize her sentiments by making a variety of noises. She is diapered, as she has been since she was an infant.

She has a sleep disorder. It is very common for her to go three or four days at a time on as little as 2 or 3 hours sleep – TOTAL.

She is prone to falls when she gets this tired because she still fights sleep and keeps walking. This is why she wears a helmet. Also like many NFL players, Jeanne wears hip protectors due to her severe osteoporosis to protect in the event of a fall.

Despite all these precautions, Jeanne suffered a severe leg fracture this year while doing nothing more extreme than simply sitting down on her couch. All her life Jeanne has loved to walk. It's been one of her few simple pleasures in this world. She would hold your hand and could safely walk on the pathways though the Ludeman grounds.

Jeanne has always received excellent care at Ludeman. Currently, that has been extended to include physical therapy to try to get her to walking once again.

Despite the way our SODCs are often negatively described, Jeanne is not "warehoused" in a state facility. Jeanne lives at the Ludeman Developmental Center in Park Forest at a home with 9 other residents. She is cared for around the clock by people with names like Julie, Jill, Rashida, & Lisa (to name just a few) who treat her with love and compassion.

Community placements serve some individuals very well, but my sister, as well as a high percentage of her fellow residents would be put at serious risk and inadequately served by such a community placement.

Since our parents died, my sister and I are Jeanne's co-guardians. We visit her regularly driving the 90-mile round trip and though it is doubtful she knows exactly who we are, she knows she is loved by her family and by her extended Ludeman family for whom we are grateful.


